



Strategy Description

The Exchange-Traded Funds (ETF) Investment Strategy is designed to give the client a highly diversified portfolio of ETFs among major assets classes and markets. ETFs typically have two main benefits over mutual funds: a more tax-friendly nature and typically lower internal investment expenses. The investments are carefully screened for quality and selected based on the individual and overall value they add to the portfolio. The screening process generally consists of in-depth analysis to identify a fund's risk characteristics, performance metrics, and management quality. The investments selected typically are those that perform at the top of their category in terms of our analytical metrics. The actual number of ETF's employed in a given portfolio is approximately 10 to 15 investments. This varies on the level of asset class exposure primarily depending on investment objective. ETF's are filtered utilizing, but not limited to, the following process: Risk and Volatility, Morningstar Ratings and Grade, In-Depth Management Evaluation.

Portfolio objective options include : Conservative, Moderately Conservative, Moderate, Moderately Aggressive, Aggressive

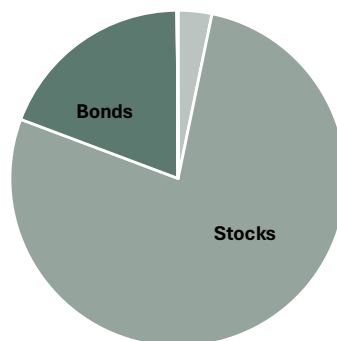

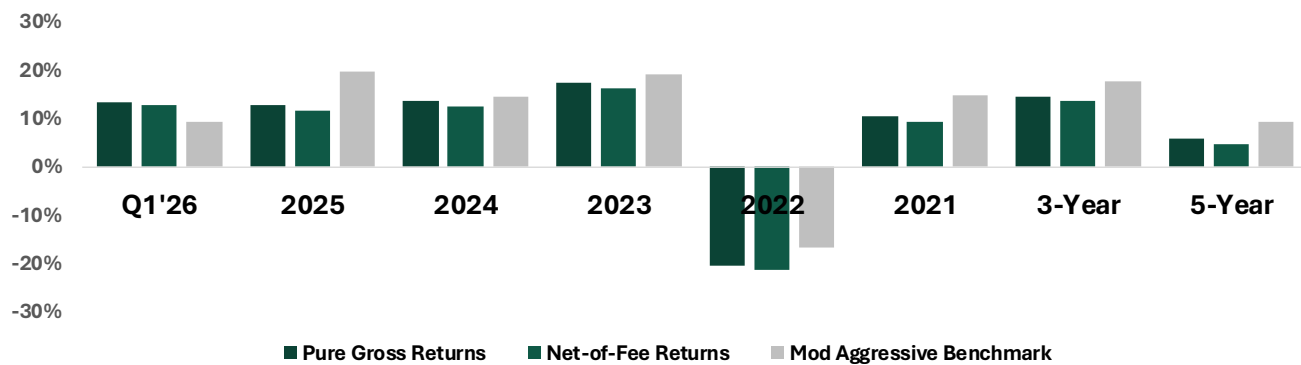

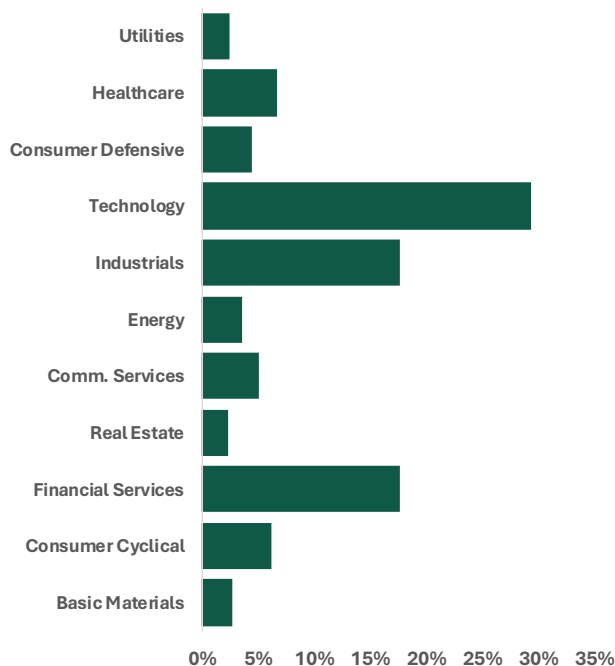

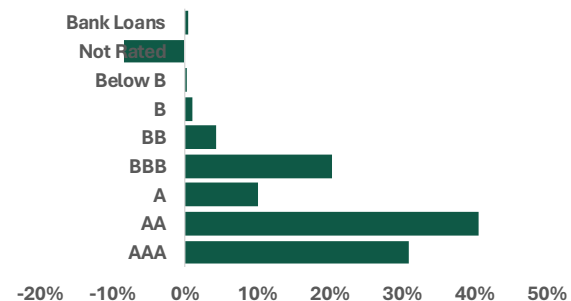

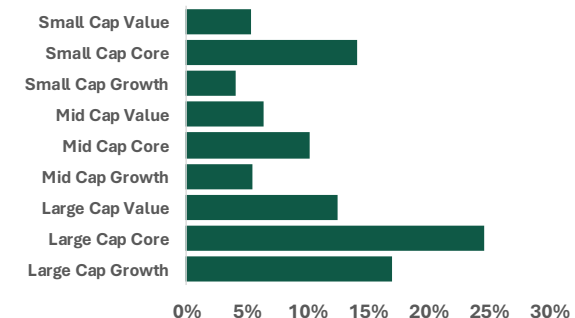
Stock Sector Exposure

The **Blended Benchmark** is a weighted custom composite consisting **20% Bloomberg U.S. Aggregate Bond Index / 80% MSCI ACWI Index (USD)**. The **MSCI ACWI Index (USD)** captures large and mid cap companies across 23 developed markets and 24 emerging markets countries with coverage of ~85% of the global investable equity opportunity set. The **Bloomberg U.S. Aggregate Bond Index** is a market-value-weighted index of fixed-rate, publicly-placed, USD denominated, and non-convertible investment grade debt issues with at least \$250 million par amount outstanding and at least one year to final maturity. It is not possible to invest directly in an index.

Composite returns reflect the reinvestment of income and capital gains and are calculated and stated in USD, and periods over one year are annualized. Gross of fees performance does not include trading costs, management fees, or other expenses that would be incurred by a participant portfolio, but does reflect the expenses of any underlying fund and ETF investments. Net of fees performance reflects deduction of the maximum annual management fee of 2%. Management fees can range from 0.20% to 2.00% and are based on client and adviser agreement.
